## **GUEST SPEAKERS**

**Village Defense** – Sharath Mekala, Michael Daniely, and Nathan Black from Village Defense gave a presentation about their public safety program. The purpose of their business is to provide an additional information system to communities: After a crime or suspicious activity has occurred and 911 has been called, the witness calls the Village Defense hotline, who in turn transmits the information via phone, text message, or email to other community members signed up through the Village Defense program.

Eight Atlanta neighborhoods have signed on so far. The system can also be used to encourage people to attend upcoming community events.

Village Defense costs \$30 per 6 months per person, or \$50 per year per person. More information: www.villagedefense.com or 678-608-4656.

**Police Report** – Lieutenant Algeo from the night shift gave a report about crime statistics in Beat 401 and 402 (Westview's Beats). He additionally informed some Beats in the city will be re-shifted, including an increase of Beats within Zone 4, equaling 15 new officers, by summer 2011. He informed of the COPS Program, a new program specifically targeting community based issues.

Major Bryant provided additional information about the re-zoning. Major Bryant is challenging neighbors to think about ideas that involve making neighborhoods safer without using requests for more police as the only solution.

**Denny's Super Save LRB (Change of Ownership)** – Satwinder Singh Tucker is selling the Denny's Super Save business at 1562 Ralph David Abernathy Blvd to Mussie Tesfamichae. Mr. Tesfamichae assured residents they will not sell single beers in coolers by the front door. Neighbor's suggested adding barriers to prevent illegal dumping. Mr. Tesfamichae has pledged to actively participate in the community.

Mark Malaguerra motioned to approve the change of ownership. John Davis seconded the motion.
