Zone 4 Police - Lt. David Ferguson reminded that a Beat re-alignment recently took place. He additionally provided an overview of crimes related to the Westview neighborhood.

OLD BUSINESS

1556 Stokes Ave. – The WCO is scheduled to be deeded the property from UCDC in January. The WCO applied for a grant through the NPU-T/City of Atlanta and has been rewarded money to put a fence around the property. The WCO will additionally re-apply for the second round of the "Love Your Block" grant.

Olympian Park Application – The Atlanta Development Authority/Park Pride informed the WCO that it will not currently take on the park conversion project. Scott Smith suggested the community should reach out to the property owners to have the land donated. Patrick Berry added that the City's short term project plan included the potential park, but listed it as "private funding."
