  - i. Mrs. Pat wanted to know if there was some entity or group that could assist the neighbors being displaced so that they get the proper buy out for their homes.
  - **ii.** Might need to coordinate w/ NPU to reach a bigger audience.
  - **iii.** Suggested by Jake that this could be included in the membership drive/door knocking campaign as an opportunity to share this information with the neighbors who are unable to attend meetings/FB.
  - iv. Mrs. Pat suggests having a leader on each street that can disseminate the information.
    "Block captains" is something we have discussed in the past but we have never been able to fully implement it. Mrs. Pat is willing to spearhead this group. Interested parties can meet after the meeting to get the ball rolling.
