WHEREAS, the residents and property owners in the Westview neighborhood worked with various consultant teams pro bono to develop a vision and approach for redevelopment and growth based on community consensus; and

WHEREAS, this planning document entitled Westview Neighborhood Master Plan, has been developed based on the direct input of the residents, property owners and other stakeholders in the study area; and

WHEREAS, this document meets the minimum planning requirements and has been reviewed by the Office of Planning; and

WHEREAS, the City wishes to adopt the Plan as a guide for future development and to incorporate the plan by reference into the 2008 Comprehensive Development Plan (CDP).

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS
AS FOLLOWS:**

SECTION 1: The Westview Neighborhood Master Plan attached hereto as Exhibit "A" and incorporated herein by reference, is hereby adopted.

SECTION 2: The City of Atlanta 2008 Comprehensive Development Plan (CDP), as amended, is hereby further amended by incorporating the Westview Neighborhood Master Plan into the CDP.
