

WHEREAS, the residents and property owners in the Westview neighborhood worked with various consultant teams pro bono to develop a vision and approach for redevelopment and growth based on community consensus; and

WHEREAS, this planning document entitled <u>Westview Neighborhood Master Plan</u>, has been developed based on the direct input of the residents, property owners and other stakeholders in the study area; and

WHEREAS, this document meets the minimum planning requirements and has been reviewed by the Office of Planning; and

WHEREAS, the City wishes to adopt the Plan as a guide for future development and to incorporate the plan by reference into the 2008 Comprehensive Development Plan (CDP).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS AS FOLLOWS:
